ACPE's Spiritually Integrated Psychotherapy (SIP) Training Program serves mental health professionals (i.e., counselors, clinical social workers, marriage and family therapists, pastoral counselors, psychologists, psychiatrists, addiction specialists, graduate students) and others in developing knowledge, skills, and ways of being for effectively and ethically addressing spirituality, religion, and the search for meaning in mental health care. ACPE's SIP Training curriculum is presented in two levels, with Level 1 being a pre-requisite for Level 2.

- Level 1 training includes five 3-hour courses which describe foundations and ethics for Spiritually Integrated Psychotherapy, describe and role-play methods for developing spiritual conversations, conducting spiritual assessment, and applying interventions for working with spiritual resources and spiritual struggles.
